Please Note:

The Registration fee covers the passport, microchip, foal parentage verification through DNA analysis, and standard postal delivery.

WSI will send the marking chart and microchip to your vet. Please supply complete contact details.

The foal owner grants permission to WSI: (1) to collect and use DNA samples from the foal; (2) to use the samples for parentage testing and in the WSI-KWPN genomic research program; (3) to award predicates to the foal based on the results of the analyses, and to publicize the awarded predicates and inscribe them on the foal's passport; and (4) publish results of the research program.

WSI strongly recommends that passports be sent only by Registered Post. If you choose to receive your passport by standard postal delivery WSI cannot be responsible for loss of the passport in transit.

Please ensure the stallion covering certificate has been issued to WSI by the stallion owner or agent.
